CAUL ACHIEVEMENT AWARD 2010:

Nomination of Samantha Searle, Data Management Coordinator, Monash University

Introduction

Samantha (Sam) Searle has been the Data Management Coordinator at Monash University since 2008. She was the first person to be appointed to such a role in Australasia, and one of the first in the world. In this role she has led activity in data management both within the Library and across the university, including the development of data management policies and procedures and the institution of programs and training for Library staff. She has worked with researchers, interpreted government policies and frameworks into the institutional setting and supported the university's management, storage and access to research data. She has been an important resource for the Australian National Data Service (ANDS) and has made all of her work available to other institutions through articles, presentations, visits and an open web site.

Contribution to research

By embracing a leadership role, Sam has demonstrated what can be done and has made a significant contribution to the CAUL strategic agenda, particularly Contribution to Research, as shown below:

- Development of governance structures within Monash.
- Development of a data management framework and 5 platforms for activity.
- Development of the Library's efforts to disseminate Monash research outputs as widely as possible using the Monash University ARROW Repository.
- Contribution to the development of the Monash's Research Data Management Policy and Procedure.
- Coordination of data management activity across Monash, including acting as a link between the Library, the Monash eResearch Centre, Information Technology Services and Records and Archives.
- Development of the data management web site, http://www.researchdata.monash.edu/.
- Development of new services and new directions in the area of data management services, http://www.researchdata.monash.edu/resources/dataleaflet.pdf
- Provision of leadership not only to Monash but also nationally, through ANDS and more generally. She has posted all the Monash work to ANDS information distribution networks, including her evaluation reports, communication plans and polices and procedures, and has contributed to a range of policy debates, including on NeCTAR and database definitions and reuse. Because Monash has been an early adopter, Sam's work has been a resource for other libraries. See attached supporting documentation highlighting Sam's communication, advocacy and outreach activity.
- Support for Monash's professional development strategy, DARE, which is designed to
 equip contact librarians and others to provide a data management advisory service. Sam
 provides leadership and resources for this strategy, which is gradually building as librarians
 take on new roles and include data management in their duties.
- Building capability through training of students and researchers, including seminars for Higher Degree Research (HDR) students, online modules and development of toolkits and checklists. Session evaluations indicate that 85% of participants rate them as "Extremely useful" and "Useful".

Conclusion

Sam Searle has made an important contribution to the CAUL goal Contribution to Research, where she has taken a leadership role in the management and facilitation of access to data and has supported the Library's wider scholarly communication and information management roles. She has contributed to the value proposition of university libraries in a changing and diverse environment. She has led and supported the effective development of the framework for data management, overseen the inclusion of data management activity in the university's day-to-day operations and provided a platform that helps redefine the role and value of libraries within their institutions. This has been achieved through extensive collaboration with researchers, librarians, e-Research and Information Technology staff across the university and externally.
