Key Activities

- CLTAC undertook an environmental scan to use as a basis for its monitoring of changes in the sector.
- A CAIRSS copyright workshop focussed on risk management.
- A CAIRSS guide to repository statistics was published.
- COSIAC published a monthly update on open access information and events.
- A joint COSIAC/CEIRAC ThinkTank on "Access to Scholarly Information" was held.
- CEIRAC is working with a number of major publishers in the development of new pricing models.
- A review of CAUL's financial controls was completed with most recommendations, including the establishment of a finance advisory committee, implemented immediately.
- A survey of members' digitisation activities, infrastructure and plans was undertaken.
- CCSAC revised the CAUL Principles for Library Services to Onshore and Offshore Students at Remote Campuses.
- Members endorsed CCSAC's recommendation to raise the standard national document delivery charges by 20%, but foreshadowed the development of a more measured and transparent process for future consideration of charges.

Collaboration

- One joint Executive meeting of ACODE, CAUDIT and CAUL was held during 2011.
- The three organisations contributed to the planning of the CCA-EDUCAUSE Australasia conference held in Sydney in April, 2011 The Game has Changed, and a partnership agreement for the management of future conferences was finalised.
- CAUL contributed to the development of Libraries Australia through its representatives Anne Horn and Liz Burke.
- CAUL members & staff participated in international meetings of SCONUL, IATUL and ICOLC.
