Sue's career has spanned the UK, New Zealand and Australia, including roles as Dean of Learning Services at Edge Hill University, UK, University Librarian at Victoria University of Wellington, New Zealand, and CEO and State Librarian, State Library of Victoria. Sue is currently University Librarian and Director, Libraries and Learning Services | Te Tumu Herenga at the University of Auckland | Waipapa Taumata Rau, in Aotearoa New Zealand was recently appointed to the CAUL Board through to 30 September 2024.

Sue has undertaken a range of professional leadership roles at local, national and international levels and is currently also Chair of CONZUL. A proud Lancastrian, Sue officially became a Kiwi citizen last year, though will probably never sound like one.

Inspired by the progress of Te Tumu Herenga in embedding Te Tiriti o Waitangi in all the work we do, her topic focuses on the transformation of libraries to meet the needs of Māori. Prashant Pandey is the Director of Library Services at Flinders University and a member of the CAUL Board. With over 18 years of experience in Library and Information Science, he has a successful track record of leading strategic change and cultural transformation towards continuous improvement of client experiences. Prashant is particularly interested in ethically applying emerging technologies, such as artificial intelligence, to improve the quality of life and ensure libraries remain relevant in the digital environment. He is a member of several industry committees, including the Board of the Networked Digital Library of Theses and Dissertations (NDLTD) and the IT-19 Subcommittee at Standards Australia. Prashant also serves as the editor of the Journal of Electronic Theses and Dissertations (J-ETD).

Chief Information Security Officer (CISO), Information and Digital Services, Flinders University

Kim Valois is the Chief Information Security Officer for Flinders University in Adelaide, South Australia where she leads cybersecurity and identity management for the University. Indigenising Libraries: Perspectives from Aotearoa New Zealand and Canada

The draft CAUL Strategy has identified indigenising our libraries as a significant priority. This session will enable CAUL members to hear perspectives, initiatives and learnings from Canada and Aotearoa New Zealand. Whilst each country, each organisation and indeed each library are traversing their own unique path and are at different stages of the indigenisation journey, the speakers will share common themes and offer insights and lessons learned to date.

Al-Powered Education: Exploring the Role of ChatGPT and Its Impact on the Future of Work

Chaired by Prashant Pandey, CAUL Board Director, Director of Library Services, Flinders University

Artificial intelligence (AI) has the potential to revolutionise many areas of our lives, including the way we communicate. One of the most exciting and controversial areas of AI research today is the development of language models, such as GPT (Generative Pre-trained Transformer) models, which can generate human-like text based on large datasets. While these models have many potential benefits, they also raise significant ethical and technical challenges, including the potential for bias, misinformation, and abuse.

This session will bring together three experts in the field of AI and natural language processing to discuss the potential and risks of AI language models, with a focus on the GPT model developed by OpenAI. The panel discussion will explore the ethical implications of AI language models, the potential for bias and harm, and the need for responsible development and use of these technologies within higher education. Attendees will have the opportunity to engage with the panellists during the Q&A session. This session is a must-attend for anyone interested in the future of AI and its impact on future of work.
